THECB Approves SOP Abilene Expansion

As most of you probably know by now, the Texas Higher Education Coordinating Board on January 26 approved TTUHSC's plan to expand the pharmacy program into Abilene. The Abilene site will join Dallas-Fort Worth and Lubbock as satellite campuses to our main campus here in Amarillo.

The first classes for the Abilene program are scheduled to begin in August 2007 with 40 students, which will expand our class size from 88 to 128 per year. Like Amarillo, the Abilene satellite campus will offer all four years of our Pharm.D. program. That means there will be 160 students in Abilene by the start of the 2010-2011 academic year.

A group from Abilene approached TTUHSC in the fall of 2004 about the possibility of expanding the pharmacy program to their city. The group, known as the Abilene Community Partners, includes the City of Abilene, the Economic Development Corporation of Abilene, Hendrick Health System, Sears Methodist Retirement Centers, the Dodge Jones Foundation, the Dian Graves Owen Foundation and the Shelton Family Foundation.

ACP has pledged \$14 million to date, which will subsidize the program through FY2011 and pay for the land and construction of a 36,000-square-foot facility for the program. The facility will be constructed on the grounds of the Hendrick Medical Center campus near downtown Abilene.



Getting the Abilene program up and running will undoubtedly require some long hours and hard work for many of us, including many faculty and staff in Amarillo, Lubbock and Dallas-Ft. Worth. But I'm certain we can all pull together and help bring the same high quality program to Abilene that we have established at our other program sites.

Poison Center Leads Carbon Monoxide Project

The Texas Panhandle Poison Center recently coordinated a very worthwhile project whereby Kidde Nighthawk carbon monoxide alarms were distributed and installed free of charge to all 210 Amarillo households that receive Meals on Wheels.

TPPC educator *Ronica Farrar* and the TPPC staff worked with the Junior League of Amarillo and the Senior Advantage Program of NWTHS to make the project a success. The first half of the distribution took place January 12 and covered the NWTHS Meals on Wheels routes. The second half took place January 13 along the BSA routes.

According to the *Journal of the American Medical Association* carbon monoxide is a deadly poison responsible for up to 2,000 deaths every year. In Texas alone in 2005, the Texas Poison Center Network handled 328 exposures, including two deaths and 50 cases where those affected suffered moderate to major effects. Ronica says these incidents are all preventable with the installation of a carbon monoxide alarm and that the elderly are among those most susceptible to carbon monoxide poisoning.

SOP Student Organizations Prepare for Health Fair

The student organizations at the SOP are putting together a health fair March 11 from 9 a.m. -3p.m. at the Ambassador Hotel in Amarillo. Each organization will sponsor a booth and is seeking student volunteers and preceptors for the event. Activities will include: cholesterol, blood pressure, glucose, and osteoporosis screenings as well as information booths on smoking cessation and nutrition.

Dr. Sherry Luedtke (Associate Professor, Dept. of Pharmacy Practice – Amarillo and Associate Dean for Professional Affairs) says the event is particularly in need of faculty preceptors to supervise the screenings and to assist the students as they disseminate information.

Dr. Luedtke says the health fair is a way to combine most of the smaller individual screenings held each semester into one large event.

"We are attempting to consolidate many of the screenings into single large events as we know that it is difficult for faculty to volunteer time with their own busy schedules," Dr. Luedtke explained.

If the event is successful, Dr. Luedtke hopes to work with the student organizations to hold similar events at each campus, hopefully in the fall and spring.

"We'd love to have faculty from Lubbock or Dallas assist in the event and then hopefully provide some guidance for an event like this on their regional campuses in the fall," Dr. Luedtke said.
