



Congratulations on your admission to Texas Tech University!

All Texas Tech students born after December 31, 1956, registering for classes at Texas Tech University **must provide proof of adequate measles, mumps, and rubella immunity**. You must provide proof of two MMRs (measles, mumps, and rubella) given during your lifetime, the first one given on or after your first birthday, and the two doses must be at least 30 days apart. **If attending on a student visa, please see reverse side for additional requirement.**

The following options are available for you to meet this requirement:

- a) You may mail or fax (806 743-2122) your immunization record with the top portion of this form (Part I) completed. Your most recent immunization records may be on your high school transcript.
- b) You may have your healthcare provider complete Part II of this form.
- c) If you have not had your second MMR, you may get this immunization at our Health Care Center on campus for a fee. Please call 743-2848 for an appointment.
- d) You may bring a copy of your immunization record to Red Raider Orientation to give to SHS personnel during registration.

**Failure to meet this requirement by the 5th week of your first semester will result in a block on your records, preventing registration for the following semester.**

## Visa Student Requirements:

If you will be attending Texas Tech University as a new student or transfer, and you are on a “Student Visa” through the U.S. Immigration and Naturalization Services (INS) you will be required to have a tuberculosis screening test if your citizenship is from a country identified as high-risk for tuberculosis.

Visa students who are citizens of high-risk countries are required to have a tuberculosis-screening test called a Mantoux skin test done within the first 5 weeks of classes. After the 5th week of classes any student who has not completed the screening or shown documentation of having had the screening will have their registration placed on hold until they meet this requirement.

The Mantoux skin test may be done at Student Health Services for a fee.

We will also accept test results from other physicians and clinics if the document:

1. Indicates it was a Mantoux skin test.
2. The test was performed in the United States.
3. The test was done in the last 12 months.

Students who have had a BCG vaccination are still required to have the Mantoux skin test. **If you are going to need a Measles-Mumps-Rubella (MMR) vaccination, please test for TB first because the vaccination can affect the results of the Mantoux skin test.**
