



Toward Excellence, Access & Success (TEXAS) Grant Program Guidelines for 2018-2019

Program Purpose

The purpose of the Toward Excellence, Access, & Success (TEXAS) Grant Program is to provide grants of money to enable eligible students to attend public institutions of higher education in this state.

Student Eligibility Requirements *

- To receive an award through the TEXAS Grant Program, a student must:
- Be enrolled at least three-quarter time as;
- An entering undergraduate student who
 - ▪ graduated from an accredited public or private high school in Texas;
 - ▪ completed the Recommended or Distinguished Achievement high school program (or its equivalent); and
 - ▪ enrolled in an undergraduate degree or certificate program at an approved institution within 16-months from high school graduation having not accumulated more than 30 SCH's (excluding credits for dual or concurrent enrollment, or by examination); OR
- An entering undergraduate student who
 - ▪ earned an associate's degree from a public or private nonprofit institution of higher education in Texas, and
 - ▪ enrolled in an eligible institution within 12 months after receiving the associate's degree
- An undergraduate student who previously received a TEXAS Grant award as an entering undergraduate student
- Be registered with Selective Service, or be exempt
- Show financial need (see the award amount section below)
- Maintain satisfactory academic progress (see the SAP sections below)
- Be classified by the institution as a Texas resident
- **Have not been convicted of a felony or crime involving a controlled substance**
