Evidence Synthesis Committee

The Committee is working on a Memorandum of Understanding to outline agreements and expectations between librarians and review teams. We will discuss it in the next quarterly meeting.

The next quarterly meeting has been scheduled for Wednesday, March 01, 2023 at 11:00 am.

I have learned that Covidence has a feature that automatically flags articles the are possible randomized controlled trials. It is based on the *Screen 4 Me* algorithm created for Cochrane editors. To activate the filter, go to settings and click the box. The box is located underneath Area of Research drop-down menu.

I have also learned that Bernadette Coles, from Aberstwyth University in Wales, is the coordinator of the Cochrane Methods Information Retrieval Group.

I am continuing to read chapters from the *Cochrane Handbook on Systematic Reviews of Interventions* and highlighting points to be included in an eventual infographic.

Kat is continuing to pursue various CE opportunities and also has been communicating with a nursing team about a possible scoping review.

Peggy has completed the searches for the neuropsychiatric sequelae of Covid-19 scoping review and is in the process of writing the searching methodology report.

On Wednesday, January 11, 2023, I had a one-on-one session with Amanda Key, MSIII to discuss a research project and determine the appropriate review methodology. We conducted searches in PubMed and Embase.

Dan currently has 3 reviews that he is involved with.
