Systematic Reviews/Meta-Analysis Committee

I downloaded the Consort Statement Checklist on guidelines for reporting RCT's and the explanatory article.

I created a presentation and hand-out on the PRISMA-S statement and the Equator Network that I discussed at the monthly Public Services Meeting.

Cochrane presented a free webinar on "PRISMA-S: an extension to the PRISMA Statement for Reporting Literature Searches in Systematic Reviews." It was packed with good information. While it will be presented again through MLA in August, there is an additional fee despite CE Passport. I am analyzing the article *Epidemiology and Reporting Characteristics of Systematic Reviews of Biomedical Research: A Cross-Sectional Study.* I sent an email to the SRMA Committee members with a link to this article and recommended that they read it. It is a study on the problem of bias in systematic reviews. I am analyzing the numbers reported in the narrative vs the numbers reported in the tables to get a better picture of the meaning of the results of the study and the investigators interpretation of the meaning. I have divided up the data, have copied the information into a word document, and have started creating a teaching PowerPoint. I have written a problem statement, overall teaching goal, and a background summary. I have also downloaded several PDF's from the article's bibliography. All of this will provide the foundation for the development of teaching points for the SRMA Committee as well as researchers wanting to conduct a SRMA.
