Evidence Synthesis Committee

I had a request from Jacob Harder MSIII, for a SRMA. His review topic was already registered in Prospero by another team in Japan.

I worked with Erum Inamdar and Julie St. John from Public Health on a possible scoping review on dental trauma in survivors of physical abuse. This turned out to be a very narrow topic and I found nothing in the literature. I also advised them standards and time frames for conducting evidence synthesis. Dr. St. John said she did not realize how long they took. The student needs to complete a paper in several months-time before she graduates. They are discussing other topics. Suzanne observed the Zoom interview with Erum Inamdar.

Cam Mecham is in the process of finishing up his review in preparation for publication. I am looking at all of the work I have done for the team so far to determine what else needs to be done.

I am working on a new review on patient implicit bias when interacting with a physician with perceived diverse sexual identity and the impact on patient care. TTU has a database called Gender Studies Database that also covers sexual diversity issues in which I located relevant articles. Suzanne help me by running a search in PsychInfo.

Shannon did a review on research screening measures on anxiety in pediatrics. She needs 1 more class to complete MLA's Level 1 Systematic Review Services Certificate.

Suzanne contacted MLA and Passport courses can now be used toward the SRSS certificates. She is beginning to go through the Passport courses for the SRSS certificate. She has worked through most of the tutorials in the Cochrane Interactive Learning modules.

Dan is working on 2 scoping reviews and 3 general review projects.
