Evidence Synthesis Committee

Amy has ordered a print copy and subscription to the e-book *Principles and Practice of Systematic Reviews and Meta-Analysis* that Dan found. He interlibrary loaned it and showed it to me. It looks terrific - the Table of Contents lists everything that needs to be done when conducting systematic reviews and meta-analysis.

Practice Guidelines have two reporting standards and checklists. One is from *AGREE: Advancing the Science of Practice Guidelines* at <u>agreetrust.org</u> and the other is from *RIGHT: Reporting Items for Practice Guidelines in Healthcare* at <u>http://www.right-statement.org/</u>

I have done some background work and initial searching for an evidence synthesis for Dr. Cameran Mecham on *Reliability of a Core Competency Checklist Assessment in the Emergency Department: The Standardized Direct Observation Assessment Tool.*

I have updated my Covidence PowerPoint.

I am continuing to work on a review on treatment guidelines for headache pain for Dr. Miles Day. This review has necessitated the use of validated search filters for study types such as clinical trials, etc. Shannon has observed me during some of the search processes for this review. We had an initial team meeting yesterday.

I emailed Dr. Ben Baronia a copy of the *RAMESES II reporting standards for realist evaluations* by G. Wong et al published in BMC Med. 2016 Jun 24;14(1):96. doi: <u>10.1186/s12916-016-0643-1</u> PMID: 27342217; PMCID: <u>PMC4920991</u>

I am continuing to work on evidence synthesis reviews with Dr. Regina Baronia and Dr. Wali Yousufzai, and Dr. Brian Kendall.

Kat Stapes is working on a scoping review with a nursing team.

Dan Stuart is working on six reviews.

Margaret Burnett has run preliminary searches in Cochrane, Embase, Ovid Medline, Pubmed and Prospero for the Ron Hall review that she is teaming with me on.
