Systematic Reviews/Meta-Analysis Committee

I emailed some links to resources about EBM and SRMA's to Rebecca in Odessa. I also gave her access to the SRMA Box folder and emailed her instructions on how to access.

I had a Zoom meeting with Becky, Erik, and one of the Permian Basin residents regarding a SR. I did some prep/organizing work for it and emailed Becky and Erik about some more resources. The resident has some good basic knowledge about SR's and was very responsive to suggestions. She committed to going through the *Cochrane Interactive Learning* tutorials. Becky and Erik are going to continue working with her.

I heard from Travis saying he wants to continue being a member of the SRMA Committee. He mentioned he has a request for a scoping review. That prompted me to create a Box Folder with 14 documents about scoping reviews. I also sent him info about MLA Passport and the webinar on Scoping Reviews. I notified committee members about the folder.

Margaret Vugrin attended a Joanna Briggs Institute Webinar. She asked me if I had any handouts on steps in doing SRMA's. I emailed her an MLA Webinar Slide handout as well as a link to a steps illustration from Weill Cornell's LibGuide. She recommends the MLA Webiner Better, Faster: An Introduction to Systematic Review Automation Tools Webinar that is freely available via Passport. The recording is now available. She showed me 2 of the tools: dedoose and NVIVO. She also told me about SR Accelerator which has some awesome capabilities including a word frequency analyzer, a search refiner, a polyglot search, a deduplicator, a screenatron, and spidercite. She also shared slides and a resource list from the MLA Webinar on SRMA Protocols that she took. I emailed them to the Committee. Additionally, Margaret told me about a 30-minute webinar that I also viewed called Scholarly Snippets: Reviews of the Literature: Getting Started presented by Molly Montgomery, Library Director of the California Health Sciences Center. It is a succinct overview of what is required when doing a review. The recording has been posted to You Tube. Another app Margaret showed me is Padlet. It produces a wall layout for websites. I think she has talked to Dan about these apps/resources for the Trends Committee.

• used tools in *Research Rabbit* and *SR Accelerator* to obtain more data about relevant articles by using articles I had previously put into Covidence for this review. I used *SR Accelerator's* word frequency capability to produce a list of keyword concepts to help him do a better job of focusing his review. By inputting sentinel articles into *Research Rabbit*, the software identified related articles.

Research Rabbit works in conjunction with <u>Zotero</u> for large file downloads, but not *EndNote* or *Mendeley*. In the future, Paul is going to help me set preferences etc. for both *Zotero*, *Research Rabbit*, and *SR Accelerator*.

One of the things I learned from the MLA webinar *From Protocol to Publication* was to set a day of the week to always send a report of progress on a review to the investigators and to set a precedent for them to do the same. Dr. Baronia and I have agreed to do our progress reviews on Fridays. So far, this is working well!
