Margaret Burnett and I are continuing to work on MLA's Systematic Review Specialization Certificate.

Paul organized a Zoom meeting including myself, Dan, Amy, and Becky and Phil White and Rebecca Daiber from Covidence to discuss Texas RAMP certification for Covidence. I recorded the meeting and sent the link to Stephanie who was not able to attend. Texas RAMP requires new security guidelines and certification that could have potentially stopped our contract with Covidence. TTUHSC IT Security had flagged Covidence because the company is based in Australia. Phil White of Covidence sent an email explaining that among other things Covidence has no integration with proprietary systems or organizational systems and there is no confidential information in it. Paul sent us an email on Tuesday, October 4, 2022 quoting TTUHSC IT Security that "*The new documentation for TX-RAMP (TX-RAMP Program Manual 2.0) indicates that Covidence will be "out of scope" and not require TX-RAMP certification. I have approved the contract for IT Security.*"
