On Tuesday, September 7, 2021, Kat, Margaret Vugrin, and I attended the first of a 2-part webinar *How to Integrate Cochrane Interactive Learning to Deliver Systematic Review Training for Early-Career State Healthcare Researchers.* They gave an overview of *Cochrane Interactive Learning* followed by a discussion of Lund University's program that is part of a larger program on evidence-based medicine that is integrated into their curriculum. Their extensive program has been increasingly developed over a period of ten years. I had hoped for something focusing on how to get started; perhaps this will be addressed in Part 2 that will take place later this month.
