Director's Corner

Welcome Back, Students.

The beginning of the academic year was marked by a limited reopening of the libraries! We are delighted to see students coming to the library after being closed for over 5 months. On September 1st, we opened our doors to a limited number of students, Monday to Friday, 7:30 am to 5:00 pm.

We opened to allow a 50% capacity of students to use the libraries. The daily average over the first two-week period was below what we expected. In Amarillo it was 10, in Lubbock 25, and in Odessa about 20. Everyone who came into the libraries is complying with the mask, hand washing, and distancing requirements. In Lubbock, the students are entering the library in roughly equal numbers through the front door or the Pod D hallway.

We asked students to complete a voluntary survey (paper or online). So far it indicates that entering students are from the Schools of Medicine, Nursing, and Health Professions. Not surprisingly, the overwhelming reason they like coming to the library is to study study (especially in the rooms), followed by the friendly staff and use computers. printers and Not of surprisingly, more comfortable seating was also mentioned along with a request for more large tables close to electrical outlets. Several expressed their appreciation for keeping the study areas clean and neat and for extended library hours. Many students do their most serious studying on the evenings and weekends.

Of course, it is important to emphasize the importance of wearing a mask, washing hands, and physically distancing to keep everyone safe. This is a serious disease, some of our TTUHSC community have been personally affected, or have family members who have died or are coping with the after effects of this illness. At the same time, we don't want to lose sight of other important coping measures, like a good sense of humor as encouraged by our friend Fred (pictured here)!



On the second floor, we have moved our public computers onto tables so that students can spread out while they work. The conference room on the







BrowZine OR How to Find Journal Articles the Easy Way




Looking for Journal Access from the TTUHSC Library?

The library has purchased a new service to make this easier for you. It's similar to how you many have searched Gold Rush in the past. But many additional features are now available to you.

Navigation: Once you select BrowZine, From the 2nd tab on landing page enter your journal title and if the library has access to the journal, it will appear and you can choose the specific year, issue page for the article that you are needing. BrowZine can also be searched by SUBJECT area. Select our subject area from the BrowZine list and all the journals for that specific area will appear. Just click on the image of your journal to access articles within.

BrowZine Can Be Used on Computers, Smart Phones, and Tablet Screens.

Computer: BrowZine is the 2nd option in the black tabs on the left side of the landing page of the library.

Smart phone: App Store or Google Play...once downloaded, select your institution. Search by Journal TITLE or Subject area. Located articles can be easily downloaded, shared or exported to .ris format or directly to Mendeley, Refworks, BibTex, or as plain text.

Once you are a registered user you can save articles for later reading under "My Articles." Using "My Bookshelf" favorite journals can be tracked and the newest issue will populate the bookshelf automatically. Your

favorite journals, and the new articles released in them, will stay in sync between all your devices.

Databases: Point-of-Care

The TTUHSC Libraries have several point-of-care databases available for our patrons.

What are point-of-care databases? They refer to those tools that can be used at the patient's bedside, or point of care, for quick and reliable information. Unlike PubMed, where information is restricted to articles and their abstracts, the information in these point-of-care databases are organized into brief outlines and bullet points for easier navigation. There are mobile options for these tools - please download the TTU app to access them. Here are some of the most popular point-of-care databases available, all of which can be found in the middle section of the library's website, under "Popular":

DynaMed Plus: This is by far our most popular point-of-care database, and the one that is most similar in form and function to UpToDate. The content of this tool ranges from diseases, conditions, and abnormal findings to focused topics on evaluation, differential diagnosis, and management. Drug and laboratory monographs

developed and maintained by IBM Micromedex are also available here. Clinical Overviews (Clinical Key): This resource is located within Clinical Key – simply go to Clinical Key and select

"Clinical Overviews" from the dropdown tab next to the search bar. Clinical Overviews are concise summaries that include evidence-based information, current guidelines, and latest advances on medical conditions. They're sourced from books, journals, Cochrane Reviews, and reliable sites (such as the CDC) by a team of clinician editors.

Essential Evidence Plus: A favorite among researchers, this is an evidence-based clinical decision support tool that houses topics, guidelines, tools, images, and summaries of conditions and procedures. Topics are updated multiple times a year, and the database sources extensively from Cochrane

Systematic Reviews. An international editorial team of medical experts heads and sources information for this database.

Although there is considerable overlap of information in point-of-care databases, there is still much that is unique to each database. Finding the right point-of-care tool depends on the information you consistently need and which one has the most robust store ofthat information. Their differing format presentations will make one more to your liking than the other.

Systematic Review Information

The last decade has witnessed increased recognition of the value of literature reviews for advancing understanding and decision making. This has been accompanied by an expansion in the range of methodological approaches and types of review." This statement appeared in the 2019 article Meeting the review family: **Exploring review types** and associated information retrieval requirements that describes forty-eight types of rigorous reviews and categorizes them into seven families. For many reasons, not every research question will meet the stringent requirements of a systematic review/meta-analysis. Since there remains a lack of knowledge about the requirements of a well-conducted systematic review/meta-analysis, an excellent starting point is the 9 minute read: What makes a good systematic review and meta-analysis? In light of

the popularity of the desire to conduct a systematic review/meta-analysis, it is important to note that there are many alternatives that produce excellent biomedical information and data.

The rapidly evolving technologies and the vast amount of research being conducted on evidence practice, based on well-conducted systematic reviews and meta-analysis, speak to the vast amount of biomedical information that is available. Currently there are nine evidence-based practice centers funded by the Agency for Healthcare Research and Quality across the United States. Evidence Practice Center's produce technical reports on systematic review methodological topics and other types of evidence synthesis-related reports such as reports summarizing future research needs for a given topic. So due to this

rapidly advancing research on systematic reviews/meta-analysis, it is important to understand the foundational concepts, the steps, process, and standards required to carry out a systematic review/meta-analysis. For more information consult the free easily read guide The Centre for Reviews and Dissemination (CRD)'s Guidance for Undertaking Reviews in Health Care.

If you are an investigator that is beginning to formulate a possible research question, it must be determined as to whether or not the question has already been answered. Depending on the subject, the library subscribes to many databases that can be searched to identify studies. The following databases are examples of where to start:


