



Dr. Ashcraft holds many titles including the School of Nursing Associate Dean for Research and Scholarship, Mildred & Shirley Garrison Endowed Professor in Geriatric Nursing, and University Distinguished Professor. She is also a Fellow with both the American Academy of Nurses and The Gerontological Society of America. Dr. Ashcraft's program of research as well as academically related service advances the science of geriatric resident in long term care settings. Her research interests include communication between nurses and clinicians in long-term care, enhancing CNA performance in long-term care, and the practice of tenure in nursing education.
