Senate Resolution 22.24

(Stating the sentiments of the Student Senate with regards to number of seats within the senate allocated towards each school for the 2022-23 academic school year)

WHEREAS, the President of the Texas Tech University Health Sciences Center, Dr. Lori Rice-Spearman has expressed to the executive board this year and the previous year, that she would like for the Student Government Association's representation to proportionally reflect the enrollment of each respective school, and

WHEREAS, **Table 1.1** in the index shows enrollment data from the 28th Edition of the Fact Book and from the Registrar to use for the proscribed process stated in the TTUHSC SGA Bylaws to determine school senate seat allotment, and

WHEREAS, the School of Population and Public Health will go live this summer 2022 creating the need to ensure the students are represented starting in the fall 2022 semester, and

WHEREAS, the numbers reflect an increase of one senate seat for the School of Medicine, with the seat being added to the MS1 class, and

WHEREAS, the numbers reflect a decrease of one senate seat for the School of Pharmacy, and for the distribution of the seats within the School of Pharmacy to be proportional based on enrollment at each individual campus, and

WHEREAS, the removal of the public health program from the Graduate School of Biomedical Sciences and creation of the School of Population and Public Health requires enrollment data to be adjusted. The numbers reflect a decrease of one senate seat for the Graduate School of Biomedical Sciences and an addition of one senate seat for the School of Population and Public Health.

THEREFORE BE IT RESOLVED, that the Student Senate of the Texas Tech University Health Sciences Center will make the changes described above to its student representation for the 2022-23 academic school year.

BE IT FURTHER RESOLVED, that this resolution be spread upon the Journal and that copies be sent to **Lori Rice-Spearman**, President of Texas Tech University Health Sciences Center; **Steven Berk**, Dean, School of Medicine; **Michael Evans**, Dean School of Nursing; **Dawndra Sechrist**, Dean, School of Health Professions; **Brandt Schneider**, Dean, Graduate School of Biomedical Sciences; **Quentin Smith**, Dean, Jerry h. Hodge School of Pharmacy.
